Some board members said that they didn't want to compete with other shops. Shop and mechanic will be added to the budget. Motion by Radtke to approve preliminary budget of seven hundred sixty thousand dollars. Second by Freudenberg. Motion carried

Treasurers Report: Transit manager explained how the federal government will send money for the remainder of the year. Upon receipt of the federal money it was asked that we pay down our insurance bill.

Space Rental two cities: More details and lease agreement requested.

Shop Lease Rhinelander: More details and lease agreement requested.

Transit Manager Report: Increased one-way rides in all locations. Transit manager was at the WURTA Wisconsin Urban Rural Transit Association meeting. Some drivers will have a safety training class on October 20th.

Dispatch Job Description: Executive Committee recommend to accept dispatcher job description. Motion by Mott to accept dispatcher job description. Second by Hayes. Motion carried.
